1. DELEGATE

1.1 DELEGATE FEE

Each Umbrella Organisation (ASOIF, WOF, ARISF, AIMS), along with their International Federations and other Sport Organisations receive two (2) complimentary accreditations for the IF Forum. Additional accreditations will be charged at the rate of 500 CHF (+ 8.1% VAT for Swiss based residents) per person.

All delegate passes, whether complimentary or paid, must be for Presidents, Secretary Generals (or equivalent positions such as CEO, COO), and individuals employed by Umbrella Organisations, International Federations, and other Sport Organisations.

1.2 MEETING ROOMS AND FORMAL FUNCTIONS AT THE OFFICIAL IF FORUM VENUE

The meeting rooms and formal functions at the IF Forum 2025 venue are exclusively available for use and organisation by SportAccord and its Official Partners.

1.3 IMPORTANT NOTES

After completing the online registration process, registration (i.e., delegate accreditation, hotel booking) will be confirmed by email.

SportAccord reserves the right to change or cancel registration for the IF Forum 2025 in full or in part (i.e., delegate accreditation, hotel booking). Any changes to the registration will be promptly communicated by email.

All administration fees associated with the cancellation of a registration (i.e., delegate accreditation, hotel booking) will be paid by the Delegate.

1.4 PAYING DELEGATE PASS CANCELLATION POLICIES

If, after paying for delegate accreditation, unforeseen circumstances prevent attendance at the IF Forum 2025, a name change to another person within the organisation will be permitted at no additional cost.

1.5 VISA

It is the Delegate's responsibility to obtain an entry visa for Switzerland. The cancellation policies for the IF Forum 2025 (delegate accreditation and hotel accommodation booking) will still apply even if the visa is not granted.

1.6 PHOTO/VIDEO RELEASE

Registration and attendance at the IF Forum 2025 imply consent to being photographed and video recorded, with permission granted for these photos and videos to be used by SportAccord and its partners for marketing and social media purposes.

1.7 CONFERENCE PROGRAMME

2. HOTEL ACCOMMODATION

2.1 COMPLIMENTARY ROOM BOOKING

- SportAccord covers two (2) nights of accommodation (single occupancy standard room) for one (1) delegate from each Umbrella Organisation, International Federation, and other Sport Organisations. Any additional costs, such as sharing a room with accompanying guests, are the responsibility of the delegates from the aforementioned Organisations and must be paid directly to the Official Hotel.
- The complimentary room is available for use between 27 October 2025 from 3 p.m. (earliest check-in date) and 29 October 2025 (latest check-out date) until 12 p.m. Early check-in and late check-out requests will be evaluated upon availability. Any related charges will be applicable to the delegate.
- Any hotel room nights booked outside of the above-mentioned period will be charged to the Delegate and must be paid directly to the Official Hotel.

IF FORUM 2025 TERMS & CONDITIONS

- Complimentary rooms must be booked by 27 August 2025. If not booked by this date, the complimentary room will be released for the respective Organisation.
- Hotel accommodation Terms and Cancellation Policies also apply to the complimentary room.
- Hotel room rates include breakfast and wi-fi/internet.
- Any extras (minibar, telephone, laundry, etc.) will be charged and paid by the Delegate upon check-out.

2.2 ADDITIONAL ROOM BOOKING (PAYING ROOMS)

The Organisation wishing to book an additional room at their own cost may contact the Mövenpick Hotel directly.

Paying rooms are subject to availability.

2.3 COMPLIMENTARY ROOM CANCELLATION POLICY

If the cancellation is received:

- On or before 27 September 2025: no penalty will be charged.
- After 27 September 2025: 100% of room fees will be due. SportAccord will issue the invoice to the concerned delegate for full payment.

A name change (to someone else within the organisation) is permitted at no cost.

3. DELEGATE FEE PAYMENT

All delegate fee charges must be paid in full upon completion of registration.

Accommodation charges for any extras (minibar, telephone, laundry) or additional nights should be paid directly at the hotel upon check-out. The hotel will collect credit card details at check-in.
